**Footnotes**

REGENCY SQUARE was urged along while off the pace, moved out on the turn, came three wide into the stretch, lacked room behind rivals near the three-sixteenths pole, moved to the outside, rallied in the final furlong and closed fast to get up late. CAN'T COMPLAIN sped clear after the start, dictated terms while off the rail, responded well when asked in upper stretch, extended the lead into the final furlong, remained well clear into the final sixteenth but was denied. ALCAZAR showed some early speed then dropped back while ridden along, raced four then five wide on the turn and finished willingly for the show. JUMPIN FOR JASON broke open the stall door prior to the start, was ridden along while well off the pace, raced three then four wide on the turn, angled out in upper stretch and also finished willingly. DANNY ERL chased the pace through the turn and lacked the needed response. BUCK'S REVENGE was urged along in the middle of the field, dropped to the rail midway through the turn and failed to rally. WAR REGENT broke through the gate prior to the start, chased the pace, raced three wide on the turn and weakened. TRIBUTE TO WOLF was urged along while off the pace, raced three then four wide on the turn and failed to rally. TEIXEIRA settled well off the pace, was urged along while off the rail on the turn, shifted four wide near the five-sixteenths pole,

came six wide into the stretch and failed to threaten. EAGLE FALLS brushed with a rival at the start, was ridden along on the outside, raced five wide on the turn and failed to respond. JUSMOVE showed no speed, raced inside on the turn and was outrun. PROPER CAT brushed with a rival at the start, lacked early speed, raced four to five wide on the turn, came six wide into the stretch and was no factor. SOUTH BY RAIL was hustled from the start, moved up on the inside to chase the pace, raced inside on the turn and faded.
