STRING KING close from the start, continued to stalk second turn off the inside, collared the leader turning for home, drew clear under pressure. BLACKNTANSATLARRYs also toward the front while just to the winner's outside, came three wide into the lane, no match in the drive, second best. AUTOBEACAT one paced toward the inside, moved out a bit for the drive, finished up best of the rest. ROCKITTOWN went evenly while racing off the inside. CHOCTAW BILL raced in hand and three wide while off the pace, lacked a serious kick when asked for the drive. SNOOK asked to clear from the outside past the wire the first time, well clear, weakened. SEFAPIANO JR. broke slowly, trailed well back, displayed a modest amount of late interest after the issue had been decided. ORDINARY TIME remained back in failing to menace. KAT'S COURT tired. BLUEHARD four wide both turns, lacked a rally. FIESTY DAY backed up through the stretch.
