**Footnotes**

CAPE SEATTLE pressed the leading duo on the outside then four wide on the turn, made a bid at the top of the stretch, was put to a right-handed whip inside the three-sixteenths pole, inched clear into the final furlong and proved best under continued right hand urging. RICH ELM contested the pace, vied three wide on the turn, was asked for more at the top of the stretch, dropped behind the winner near the furlong marker and was outfinished while clear for the place. COUPLE OF HOURS was urged along on the outside, raced four then three wide on the turn, came under a drive in upper stretch and lacked the needed response while up for the show. HOUSE OF WORDS settled off the pace while under some urging, raced three then two wide on the turn, was put to a right-handed whip in upper stretch and also lacked the needed response. GREENHOUSE BANKER contested the pace on the inside of RICH ELM while a bit off the rail, dropped out in upper stretch and gave way. SILENT COUNT was urged along on the inside, saved ground on the turn and failed to rally. MUSICMEISTER lacked early speed, raced two to three wide on the turn, came four wide into the stretch and failed to threaten. STEP N IT UP settled off the pace while under some urging, was ridden along while off the rail on the turn and failed to respond.
