Footnotes

SOL D'ORO chased the pace on the outside, made a bid late on the backstretch, vied two to three wide on the turn, came under a drive in upper stretch, battled with the runner-up in the final furlong and gamely prevailed under strong urging. DUALLY AFFIRMED bumped with an opponent at the start, raced on the outside while ridden along, was carried out six wide early on the turn then dropped to the four path, advanced approaching the quarter-pole, made a bid in upper stretch, battled with the winner in the final furlong and missed. CALUSA RED bumped with a rival at the start, was urged along at the rear, went three wide on the turn and got up for the show. BELLAMY RUN broke a step slow, settled while under some urging, raced off the rail early on the turn then dropped to the inside, shifted out after turning into the stretch and failed to rally. TORTUGA'S SONG disputed the pace on the inside, dropped back late on the backstretch then bore out into the turn, went five then four wide on that bend and came up empty. MENDOCINO COUNTY bobbled at the start and was last away, raced near the back of the field, went around the turn in the two path and failed to threaten. D. J.'S TAP contested the pace on the outside, moved to the rail entering the turn, dropped back under a drive in upper stretch and tired.
