Footnotes

STARZILLA never far back to the second turn, rallied three wide to the stretch then dug in under vigorous handling and got to the front very late. CATZANOVA contested the pace to the second turn, was two wide to the stretch, drifted in leaving mid stretch then lugged inward under right handed urging, bumped and impeded BERTRANE then bested that one for second. BERTRANE dueled from the rail for six furlongs, responded to pressure to inch away to mid stretch, battled on late but was bumped and impeded in deep stretch and missed second. DUALLY AFFIRMED stalked the pace to the second turn, raced two wide to the stretch then was cut off when CATZANOVA drifted inward leaving mid stretch, checked, angled out and finished willingly once clear. SWING FOR DEFENCE was allowed to settle for five furlongs, tried to rally three wide on the second turn but could not impact rivals late. MONSAJEM MANEGE had no speed and saved ground to no avail. RUN FOR DAYLIGHT checked off heels on the first turn, settled to the half then saved ground to no avail. BURNING lugged out into the first turn and had to steady hard to avoid heels then trailed throughout. The stewards conducted an inquiry into the stretch run and disqualified CATZANOVA from second to third for interference to BERTRANE.
