Footnotes

HANDS ON showed good speed on the outside, inched clear near the seven-sixteenths pole, controlled the tempo while off the rail on the turn, responded well when set down in upper stretch, was faced with several challengers in the final furlong but held gamely under vigorous handling. TI TOWNSHIP settled off the pace, moved up while four wide and urged along on the turn, was put to a drive in upper stretch, chased the winner into the final furlong and finished willingly but missed. ROYAL AGO bumped with a rival just after the start, lacked early speed while ridden along, raced inside on the turn, shifted seven wide at the top of the stretch, rallied in the center of the course and finished fast but was too late. HIGH TONED showed good speed, dropped back near the seven-sixteenths pole, raced inside on the turn, drafted behind the leader outside the quarter-pole, came off the rail and was asked at the top of the stretch, drifted out passing the furlong marker and bothered DUBLIN DA'BET then was outfinished. DUBLIN DA'BET tracked the pace on the outside then three wide on the turn, was asked in the vicinity of the five-sixteenths pole, chased the leader through upper stretch, steadied when HIGH TONED drifted out passing the furlong marker and lost his best chance. CHARLES EDWIN bumped with a rival just after the start, settled off the pace under some urging, raced three wide on the turn, shifted out once straightened for the drive, was put to the whip near the three-sixteenths pole and lacked the needed kick. FOREST COAST bumped with rivals just after the start, was reserved on the inside, saved ground on the turn, came under a drive in upper stretch and lacked the needed response. UNEXPECTED VALOR bumped with rivals just after the start, moved up then was rated just off the pace, dropped back early on the turn, moved out at the top of the stretch and failed to rally. HOUSE OF WORDS settled on the outside, advanced five wide on the turn, bobbled a couple of times in upper stretch and came up empty. Following a rider's claim of foul, the stewards' disqualified HIGH TONED for interference near the furlong marker and placed him fifth. (Rail at 10 Feet)
