Footnotes

SWIFT EAGLE angled in and pulled his way along inside to stalk the pace, awaited room leaving the second turn, came out into the stretch, bid between foes in midstretch, gained the lead in deep stretch and prevailed under some urging. EXCESSIVE ASSAULT stalked off the rail, bid alongside a rival on the backstretch and second turn, gained a short lead, fought back between horses in the stretch and continued willingly. WARREN'S BIG CAT settled inside then went outside a rival into the second turn, continued three deep then four wide into the stretch, bid four wide in midstretch and was outfinished but edged a foe for the show. VALLEY CAT unhurried and angled in early, came out on the second turn, was fanned five wide into the stretch and finished well. TRIBAL DESERT chased inside, was shuffled back into the second turn, came out on that bend, swung four wide into the stretch and steadied off heels entering the lane but finished with interest. UNUSUAL JAZZ chased three deep then outside, angled in between horses on the second turn and lacked the needed rally. FULL INSTINCT sped to the early lead, set the pace inside, dueled along the rail on the backstretch and second turn, fought back past midstretch, then weakened. GO TO THE PULPIT stalked three deep or outside a rival, continued three wide on the second turn and lacked a rally. ST. JOEL steadied between horses early, stalked inside and weakened in the stretch. DUGAN BILL three deep early, stalked outside a rival on the backstretch and second turn and also weakened in the drive.
