QUITTIN TIME gained terms with a rival attending that foe's pace under light reserve for a half, took over leaving the midway point of the far turn and maintained a safe advantage to the end under firm encouragement. AWOL ADAM, reserved along the inside in the opening half, swung out four wide racing into upper stretch and produced a steady late response to close the gap. MR. PUMPERMICHAEL angled in a bit tracking the leaders from just out of striking distance as part of the second flight racing to the far turn, switched out racing into upper stretch and continued with a mild bid while gaining a share. MY PAL PAUL was urged to the lead along the inside in the opening stages, set the pace on a narrow margin to the second bend and gave way once headed by the winner racing into upper stretch. OFFICER MCNEAL tracked the leaders as part of the second flight while shifting out a bit on the backstretch, angled to the inside racing into the lane but had no final kick. FLAT GONE tracked off the second flight outside foes in the opening stages, shifted out three wide nearing upper stretch but lacked a rally. RIVERSHIRE was never a factor.
