PART OF MY FAMILY raced up close right off the early pacesetter, took command at the top of the lane, led by a slight margin in the top of the stretch, matched strides briefly with SCALDING HOT, dug in and held on to prevail. SCALDING HOT settled in behind the early front runners, steadily advanced position, raced three wide in the turn, edged up to PART OF MY FAMILY in the upper stretch and briefly matched strides, continued bid was unable to get by winner in the late drive. JET RAIDER was unhurried early and raced behind the pacesetters, began to advance position heading into the turn, raced five to six wide at the top of the lane, continued along the outside in the stretch and was up in time for show. SAUCY PAL showed early speed and led by a slight margin, raced near the inside and had nothing left in the drive. AUTHENTIC FLYER failed to be a threat. PHANTOM STRIKE raced near the back early and was never a factor. WAR BRIDLE raced near the inside and failed to make a bid. FORMULA APPROVED made a brief bid in the early going and steadily weakened.
