VIGILANTE LAW was well placed on the inside, moved out some near the half-mile pole, was urged along while three then four wide on the far turn, rallied under right hand urging in upper stretch, closed well to make a bid outside the sixteenth-pole, dueled with PIONEERING NATIVE late and narrowly prevailed. PIONEERING NATIVE raced between rivals on the first turn, settled off the pace, ranged up while three wide on the far turn, made a bid at the top of the stretch, gained a short lead on the outside, dueled with VIGILANTE LAW in the final furlong and just missed. JET RAIDER was well rated while setting the pace, came under urging near the quarter-pole, lost the lead in upper stretch and was outfinished while well clear for the show. BUBBLING SPRINGS was caught four wide on the first turn, tracked the pace on the outside, was asked near the five-sixteenths pole, chased into upper stretch then tired. DEVIL'S APPRENTICE moved in before the first turn, settled on the inside, was urged along on the far turn and failed to respond. AMEROCKO threw his head at the start and was off about three lengths slow, lagged at the rear of the field, passed a couple of rivals near the half-mile pole, went four then five wide on the far turn and failed to threaten. HOLLY JET raced three wide on the first turn, was urged some on the backstretch, came under stronger urging on the far turn and also failed to respond.
