RUNAWAY STEPHEN broke in, void of early foot, advanced inside, got through along the rail turning for home, bid, proved best. SHUN also back off the early pace, moved closer four wide late in the final turn, challenged upper stretch, briefly raced on equal terms with the winner outside that foe with less than a furlong remaining, second best. HARDROCK ELEVEN lacked early foot, was still back when mired in some traffic late in the final turn, four wide into the lane, clear for the drive, belated rally, up final stride for the show. SAINT FLOYD moved up to duel into the first turn, continued to alternate up front in the run up the backstretch, garnered a slightly larger advantage midway on the final turn, could not contain the top two in the drive, missed the nod for the show. ARTHUR'S COURT in tight, steadied at the start, raced back in trailing early as a result, five wide when beginning a mild advance turning for home, improved upper stretch, little late gain. JADE TRADER closest to the two leaders for six furlongs, had little left for the drive. MONEY CANNON settled in the second group, also lacked a closing kick when called on in the drive. SCRIVCO was finished after a half. LEESTOWN MAGIC set or forced the pace on the outside, stopped in the drive.
