WELL'S GOLD stalked the early pace from the inside, steadily advanced entering the second turn, altered outside but was no match while clearly second best. SHOUTFORJOY well placed early from the inside, inched closer entering the second turn, altered outside for the drive but was no match for the top two. INDY CITY dueled from the inside early but had nothing left. FINE TROUBLEMAKER dueled from between foes and tired. MADDIE'S MAIN MAN was no factor. PEGASUS PRANCER was no threat. ROY LEE was never close. WHAT'S UP POP was unprepared at the start, rushed up from the outside, came six wide into the first turn and gave way.
