RYAN'SWALKING TALL stalked the early pace from the inside, inched closer entering the second turn, responded to duel through the drive with BETTER BEE LUCKY and outfinished that one late. BETTER BEE LUCKY up close early from the outside, inched closer entering the second turn, made a bid to duel through the drive but was outfinished. BIGBANDIT outrun early, advanced outside entering the second turn, responded but could only gain the show. BITE OF SUNSHINE dueled from the outside early, remained engaged up the backstretch, held a forward position for the drive but could not match strides. HEROS SOUL pressed the early pace outside but could only improve position. ROY LEE dueled from between foes and tired. HE'S FINE chased the early pace outside but had nothing left. VERMILION KING was no factor. BAYLOR'S RODEO was no threat. SEFA'S DYNAMO dueled from the inside and tired. GROOVY BOSCO was finished after a half.
